- **young investigators** (<35 years old at the time of call deadline)
- a trial related to **digital tools** and/or **education programs to support dietary management and adherence**

Each professional, including but not limited to dietitians, clinicians and post-doctoral researchers, working with an institution active in the field of IEM can participate in this grant application.

This call seeks investigator-initiated clinical trials with a **focus on nutrition and/or dietary management that will contribute to improving clinical practice.**
